### SECURITY COUNCIL OF UNITED NATIONS TECHNICALLY LOST ITS SANCTITY ON 26 JUNE 1955

You don't have to be amongst the tens of millions of people who have died or been maimed in international armed conflicts since World War II to know that the United Nations Security Council is not working. It is also no secret to UN bosses such as Ban Ki-moon, or member state representatives such as Nikki Haley, who spoke their minds just before leaving office and had admitted that the UN, in its mission of keeping peace and security, has been "failing us" and the world is "more dangerous" now. While the creation of the UN was a major advance in world governance evolution, the birth defect of its "Security Council" was well known at the founding San Francisco Conference. Researchers at the Center for United Nations Constitutional Research (UNCR), a Brussels think tank, specializing on UN Charter and its reform, recently revealed their findings and had (re)discovered India's role.

Dr. ShahrYar Sharei, the Director of the UNCR, has brought out that, based on the 1945 UNCIO documents, India had put an expiration date of 10 years on the Security Council of United Nations and on its Veto Power. Sir Arcot Ramaswami Mudaliar, speaking on behalf of India and as a spokesman for the majority states in San Francisco who were against the veto agreed earlier at Yalta by Stalin, Roosevelt, and Churchill at the council, said: "That while they were prepared to agree to the Yalta formula over the next ten years, ... we felt that if this unanimity rule [veto] were not to be applied at the end of ten years to any proposal regarding the amendment of the Charter, we could with complete trust and confidence in the five great powers, agree to the complete Yalta formula during the intervening period of ten years."

As a great compromise, Shri Mudaliar and the anti-veto majority got Article 109(3) enshrined to the Charter of the UN which required its renewal after 10 years. In 1955 a resolution to hold a "general conference" to review and renew the Charter was adopted at the UN, but it never met, up to this day. Hence the PWP 15.

We are announcing the 15th session of the PROVISONAL WORLD PARLIAMENT (PWP) to be held in New Delhi, India, beginning on Human Rights Day, December 10, 2021.

Under Article 19 of the Earth Constitution, the people of Earth are empowered to initiate PROVISIONAL WORLD GOVERNMENT. We can begin with any of the major agencies or organs of World Government as defined by the Constitution. The main form in which Provisional World Government has been initiated to date is through holding sessions of the Provisional World Parliament.

The first session was held at the famous and elegant Royal Pavilion in Brighton, England, in 1982. It was inaugurated by Sir Chaudhry Mohammad Zafrullah Khan of Pakistan. He was former Pakistan Ambassador to the UN as well as Foreign Minister of his country. He declared "The only solution to solve the world's ills is a democratic federal world government," Dr. Max Habicht, renowned international lawyer and legal advisor to WCPA, presided over electing the Speaker for the Parliament, The Parliament elected Shri A. B. Patel, who was at that time General Secretary of the Sri Aurobindo Ashram and World Union Movement in India, as the speaker for its first-ever session.

Since that time there have been 13 more sessions of the PWP. The second session itself was in New Delhi and was opened at the famous Constitution Club by the then President of India, His Excellency Giani Zail Singh, and was presided over by the then speaker of the Lok Sabha.

The 15th session will be again in New Delhi and will be opened by a prestigious constellation of political and moral luminaries. Observers are those who have not signed the Earth Constitution. They may participate at the discretion of the PWP Chairperson but may not vote, since the legitimacy of PWP is based on the authority of the Earth Constitution.
